7) BMFA Full Council meeting Saturday 8th September 2018

BMFA budget – the surplus held by some of the areas is quite high and it has been suggested that the future yearly grants will be subject to means testing. Areas have been asked to provide a budget for the next meeting.

The 2019 BMFA subscriptions have been proposed to go up by £4 and will be voted on at AGM. A vote was held to reflect the BMFA NA view of the proposed increase.

8) BMFA online membership system
